# **Oral Health Equity**

By striving to create an oral health system that meets the needs of all children in Maine, COHN's strategic work is founded on equity as a core principle. We aim to bring preventive oral health care to children and create systems of care to connect children to treatment as easily as possible, breaking down structural and systemic barriers to care. For example, COHN partners are working to strengthen the capacity of dental providers and collaborating with community-driven organizations to better serve BIPOC (Black, Indigenous, and People of Color) communities, children with disabilities and those in the foster care system, and families who live in rural areas or in poverty.

# Addressing inequity through COHN's strategic priorities:

- 1. Providing oral health services in school and community settings removes transportation, financial, and other barriers that keep children from getting preventive care before dental disease sets in.
- 2. Integrating oral health into primary care settings brings early preventive services to the primary care setting, where most children receive consistent, regular health care from birth to age 5 with a trusted primary care provider
- Transforming the oral health system to serve all people in Maine ensures that the dental providers serving historically underserved communities are able to sustain high quality services.

# 2022 Progress on COHN's Strategic Priorities





Expanding Access to Preventive Oral Health Care in Schools, Preschools, and other Community Settings

Led by the School Action Team

LD 1501: An Act to Protect Oral Health for Children in Maine was incorporated into the supplemental budget for State Fiscal Year 2023. This orders the expansion of Maine CDC's School Oral Health Program to all schools by 2025 and restores the Oral Health Coordinator position to provide state leadership on oral health.

With leadership from Medical Care Development and the Maine CDC School Oral Health Program, COHN has been supporting the development of a role we are calling an Oral Health Navigator to provide a new entry point into public-

health oriented dental career pathways. We have been awarded funding from the Maine Department of Labor to develop this role as well as to strengthen other aspects of existing oral health career pathways.

COHN has been supporting Partnerships for Health to conduct a financial analysis of school oral health service delivery models to inform a sustainable and coordinated future system of school-based oral health care.

COHN partners compiled a resource for school nurses to explain the school-based oral health services that are already available to students and how to access them.



#### **Integrating Oral Health into Primary Care**

#### Led by the Health Integration Action Team

As the result of a strategic planning process, From the First Tooth (FTFT) will now address oral health integration for people up to age 21 and facilitate expansion of a broader range of oral health services in the medical office setting.

To bring the HIAT "integration rainbow" to life, Health Integration Action Team partners have launched several collaborative projects to design and test different models of integrating preventive dental services into primary care. These projects include building a hygienist into the primary care team, giving primary care providers the tools for E-Consults and early intervention, and producing a video series containing timely oral health information for caregivers at well-child visits.

COHN convened an historic first meeting of the Presidents of the Maine Chapter of the American Academy of Pediatrics and the Maine Dental Association. The group emerged with great enthusiasm for several shared goals to increase collaborative efforts across the leadership and membership of these two key professional associations that are well positioned to impact children's oral health.

# 2022 Progress on COHN's Strategic Priorities





#### Transforming Maine's Oral Health System to Serve all People in Maine

Led by the Maine Oral Health Funders Advisory Board

The Maine Oral Health Funders, with leadership from Maine CDC, supported the convening of stakeholders from across the state to tackle an oral public health workforce plan. The focus includes considering innovative care delivery models to maximize the reach and capacity of our oral health workforce to serve more of Maine's population in need of care.

With the expansion of MaineCare to include comprehensive oral health coverage for adults, Maine Equal Justice and Consumers for Affordable Health Care are working to help people become aware of the benefit and find a provider, and to ensure that the new benefits are implemented as effectively as possible to improve access to care among historically underserved communities.

The Maine Oral Health Centers Alliance, a group of non-profit dental centers, are working together to troubleshoot shared challenges around workforce, navigate MaineCare requirements, and advocate for policy improvements to better provide services to their patients, many of whom have had very limited access to dental care.

Until Maine has a truly sustainable oral health system that has the capacity to address the needs of the whole population, the providers serving people who are uninsured or who have MaineCare need ongoing financial support to keep their doors open. MOHF is providing operational support to the non-profit dental centers and mobile school-based programs to allow them to continue providing core oral health services until financial sustainability through reimbursement is a reality.

#### **Virtual Dental Home**


Providing children access to a comprehensive dental home with all preventive care delivered in their childcare, school, or primary care setting

During the '21-22 school year, the Virtual Dental Home Head Start pilot was active in three counties and engaged two non-profit dental offices, one mobile clinic partner, and three Head Start agencies.

With the award of Congressional Project Funding, the pilot has now expanded to nine counties, with six Local Implementation Teams aiming to provide VDH services at 65 Head Start sites in the 2022-23 school year.

#### **Oral Health Equity Collaborative**

building an oral health equity plan in Greater Portland and informing statewide equity efforts

In 2022, Cross Cultural Community Services, with support from COHN, established the Oral Health Equity Collaborative (OHEC): a collaborative of BIPOCled community organizations (Cross Cultural Community Services, Maine Access Immigrant Network, and City of Portland Public Health Division's Office of Minority Health) with key local oral health providers (Community Dental, Greater Portland Health, and Mainely Teeth), and dental

#### **OHEC** goals:

Goal 1: Grow capacity of providers who take MaineCare and have a sliding fee scale to serve more (all) families.

**Goal 2:** Strengthen capacity of providers to provide culturally relevant care to those who face additional barriers to oral health.

Goal 3: Strengthen capacity of community-based organizations to help their communities access care and achieve oral health and to develop relationships with provider organizations to continually improve how the providers do their work.

#### **Oral Health Workforce**

envisioning and creating the public oral health workforce needed to meet the needs of all Maine children


This year, COHN was awarded funding from the Maine Department of Labor/State Workforce Board's Maine Industry Partnerships for Workforce Development Initiative and from the Maine Health Access Foundation to address oral health workforce challenges.

The Oral Health Industry Partnership will grow the oral health workforce statewide by creating a new entry point on the oral health career pathways leading to dental assistants and dental hygienists, both of which are high-wage high-demand jobs. This initiative aims to expand the diversity of Maine's oral health workforce, strengthen relationships with underserved communities, and improve community-based oral health care.

# 2022 Financial Report

The Children's Oral Health Network has been very fortunate to have had consistent core funding provided by the Sadie and Harry Davis Foundation from the beginning. This funding supports our small staff and the costs of operating the 501(c)3 organization that provides backbone support for the Network, as well as seed funding for action teams and initiatives. We recruit additional project funding to pass through to partner organizations to support their capacity to work toward COHN's shared vision. We also help partners develop their own grant proposals to fund Action Team initiatives.

2022 was an exciting year on many fronts, and not least because it was a breakthrough year for securing funding for several major initiatives. In particular, we were thrilled that Senator Collins, Senator King, and Representative Pingree all helped bring Maine \$650,000 in Congressional Project Funding / Congressionally Directed Spending to support our Virtual Dental Home pilot. COHN also was awarded a State contract from the Maine Department of Labor's State Workforce Board for \$545,600 in American Rescue Plan Act funds to support a two-year initiative to develop the Oral Health Industry Partnership.





We offer special thanks this year to the Board of the Children's Oral Health Network of Maine for the past 5 years of hard work to get this Network launched. We appreciate their solid dedication and management of the resources that make it possible for the Network to do its work!
